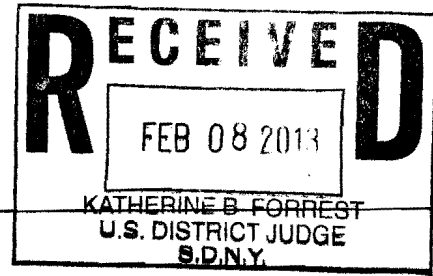
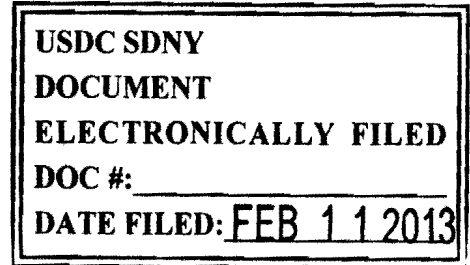

Dear Judge Forrest,

According to your personal court rules, you require that in any action in which subject matter jurisdiction is based on diversity of citizenship under 28 U.S.C. § 1331, the party asserting the existence of such jurisdictions shall, prior to the Initial Pretrial Conference, submit to the Court a letter not exceeding two single spaced pages explaining the basis for that party's belief that diversity jurisdiction exists.

This letter is that proper notice.

I am a Citizen of the Republic of New Lemuria and am a duly appointed Ambassador of that nation-state. Hence I am afforded all the protections in this matter of the VIENNA CONVENTION on DIPLOMATIC RELATIONS of 18 April, 1961, entered into force on 24 April, 1964 (United Nations Treaty Series Vol. 500) under Article 29 and Article 31 § Section 1 and § Section 2.

I am not under the jurisdiction of this US District Court, and cannot, by treaty, be made a party to this civil case or these proceedings.

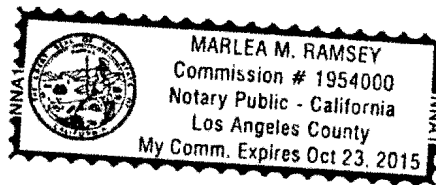


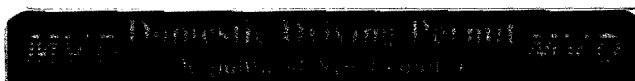
